

GBOI Privacy Policy

This Privacy Policy applies to the www.globalblueoceans.com Web site and explains the types of information we collect from you and how we use the collected information. Types of Information Collected

GBOI does not collect any personal information about you such as your name, mailing, or e mail address except when such information is voluntarily provided by you to www.globalblueoceans.com through this Web site. Whether you provide any information is entirely up to you.

The types of data collected will include IP addresses, cookie identifiers, website activity and in the cases where customer fills out a form, it will include all field information filled out by the customer.

GBOI does collect non-personally identifiable aggregate information about visitors when pages on www.globalblueoceans.com are requested through a Web browser. This information is used for analytical and statistical purposes and includes information such as a visitor's host name, internet protocol (IP) address, browser type and version, date and time of the visit, the page from which the visitor accessed the current page, the request made by the visitor, volume, traffic pattern, and related site information. GBOI may use this information to tailor your online experience on www.globalblueoceans.com.

Cookies

GBOI may utilize a standard technology called "cookies" to collect information about your use of www.globalblueoceans.com. A "cookie" is a text file that is sent to a browser from a web site and stored on a computer's hard disk. Cookies record information about a visitor to a web site, the pages that were visited by

the visitor, the date of the visit, and any preferences that may have been set while the visitor was browsing the site. This information may be used by GBOI, now or in the future, to control your access to certain features, customization of content, or to analyze your activity and behavior on www.globalblueoceans.com. Cookies cannot retrieve any other data from your hard drive nor obtain your e-mail address nor read cookies that were created by other web sites. When visitors come to our site, third parties may place cookies on visitors' browsers for targeted advertising purposes. You may avoid that by utilizing ad blocker on your browser.
